# MEMBERSHIP OPTIONS

Whatever your needs we have a membership to suit you. We offer Corporate, Family or Individual memberships. All memberships include full Topa Tower Club privileges. Facilities include the dining room, lounge, health club and tennis court. The Topa Tower Club offers an array of club sponsored social events such as Winemaker Dinners, Gallery Trips, and Member Mixers. Members are also welcome to utilize nearly 300 reciprocal clubs worldwide.

## General / Individual Memberships

**\$1,500 Initiation fee - General (one time fee)**  
**\$1,000 Initiation fee - Individual (one time fee)**  
**\$90 Monthly dues**  
**\$125 Quarterly minimum spending**

The General Membership is our most popular household account. Individual membership is for single individuals. Both memberships include full Tower Club privileges, facilities and full signing privileges.

## Corporate Membership

**\$5,400 Initiation fee (one time fee)**  
**\$90 Monthly dues per designee**  
**\$125 Quarterly minimum spending**

The Corporate Membership requires a minimum of two members, up to five memberships. Each designated employee will have their own account and separate billing. Each designee is required to fill out an application. This membership has the benefit of transferability of designees to anyone in the same company or organization.

## Corporate Plus Membership

**\$6,400 Initiation fee (one time fee)**  
**\$60 Monthly dues per designee**  
**No quarterly minimum spending**  
**Minimum of 10 accounts**

Corporate Plus allows you the membership freedom to have multiple club users. This is an ideal option for larger companies. Each member will have a separate account and will be billed individually. Includes full signing privileges.

## Corporate Life Membership

**\$20,000 Initiation fee (one time fee)**  
**\$0 Monthly dues**  
**\$300 Quarterly minimum spending**

The Corporate Life Membership allows for up to a maximum of four members. Each designated employee will have their own account and separate billing. Each designee is required to fill out an application. This membership has the benefit of transferability of designees to anyone in the same company or organization. No dues for the lifetime of the membership. All users contribute to minimum spending requirement.

## Frequently Asked Questions

### What is the Dress Code?

Business Casual dress for lunch and dinner Wednesday and Thursday evenings. A coat is required in the dining room on Friday and Saturday evenings. Jeans, shorts, sweats, tennis shoes and caps are not permitted in the club. Please advise your guest of the dress code when inviting them to the club.

### Can I use a cell phone in the dining room?

Cell phone usage in the main dining room is not acceptable. You may talk on your cell phone in the hallway.

### What is the guest policy?

You may bring guests to the club at any time. Feel free to bring guests to special events, functions, the lounge area and so forth. There is a nominal \$5.00 per person guest fee when the member is not present. There is a \$10 guest fee for the gym facility.

### Can someone else use my account without me being present?

Each member is allowed six unattended guest passes per year. Your guest must abide by Club rules and dress code. Your guests' charges can be applied to your account or they may be paid by credit card. You are responsible for all charges to your membership account. Written permission authorizing your guest to use the facilities and to charge to your membership account is required. Your guest can also pay by credit card, in which case a guest fee applies. Please include the date and time of the reservation.

### Is there a Holiday fund?

The members do contribute to a Holiday fund. The fund is distributed to the entire Club staff. The \$50 amount appears on your October statement. You may call accounting and change or decline this amount.

### What is the service charge?

18% on in the lounge and dining room, 21% on banquets. They are automatically applied to your bill.

### How do I terminate my membership?

A member may terminate his or her membership in the Club at any time by delivering to the Club's office: (1) Written resignation signed and dated by such member (2) Final balance of the account and return membership/ security cards must be accompanied with the resignation letter. Following receipt of the resignation by the Club, such resigning member shall not thereafter be charged monthly dues; however, such resigning member shall be liable for any unpaid initiation fees, any charges for use of the dining room or the health club facilities ("facility charges"), delinquency charges or membership dues (including the membership dues for the month in which such member resigns). A member shall not be entitled to use the Club facilities after resignation. If final balance is not paid within thirty (30) days of cancellation the account will be turned over to a collections agency.



## Frequently Asked Questions

### When are my membership dues billed?

Dues are billed in advance for the next month.

### When is my account balance due?

All membership fees, facility charges and all other indebtedness to the club are due and payable when presented. Any balances not paid 21 days after the statement date are subject to a 5 % late fee. Direct credit card payments can be set up by contacting accounting. MEMBERSHIP ACCOUNTS DELINQUENT AFTER THIRTY (30) DAYS MAY BE SUSPENDED OR TERMINATED, AT MANAGEMENT'S DISCRETION.

### What are Minimum Spending requirements?

Members are required to spend a minimum amount in food and beverage over a three month period. Your account will be billed the amount of minimum charge that has not been spend in the quarter. The quarters end on the last day of March, June, September and December. A la carte dining, lounge purchases, special events at the Club and banquets/meetings all count towards this minimum, while out of the club special events/trips, direct wine sales and any purchases in the spa do not.

### Accounting issues effective June 01, 2005.

This is to remind all members of the following policies on membership suspension or termination due to non-payment under Articles 2 & 3 of the Topa Tower Club's rules and regulations.

**All dues and other indebtedness to the club are due and payable when presented. Any balances not paid 21 days after the statement date will be subject to late fee.** The current late fee rate is set at 5%.

**A member who becomes delinquent in the payment of his or her account will be suspended. No notice of suspension need be given. Membership dues shall continue to accrue during such period of suspension.**

Any account that is 30 days or more past due is considered delinquent.

When the account is suspended, it will be made inactive in our computer and the member will not be able to use any of the Club's facilities as a member, or as a guest of another member. If and when the account is reinstated, a reinstatement fee of \$50 will be charged to the account. Once the account has been made current, the member needs to contact our Accounting Department during business hours in order to reactivate the account in our system.

**In the event any member fails to make full payment within thirty (30) days from the date he or she becomes delinquent, the account will automatically be terminated and turned over to our collection agency. The member will be notified of such termination in writing.** Any member who has been terminated from membership shall not be entitled to a refund of any portion of their initiation fee. No member who has been terminated will be reinstated.

Additionally, we will require all members to have a credit card on file as security deposit. The card will only be used in the event that the account becomes past due, unless specified by the member for monthly charges.
